# The International Labour Organization (ILO)



- Constituted in 1919 to promote universal and lasting peace...based upon social justice;
- Joined the UN in 1946;
- A specialized UN-agency mandated to deal with all issues related to the World of Work;
- Tripartite (ILC, GB and national partners);
- 185 Member States, including all ASEAN countries;
- The current agenda: "Decent Work for All";
- International Labour Office, the Secretariat for the ILO;
- Approx. 3000 staff (offices and projects);

# **ILO instruments - Asbestos Convention**



- Scope and definitions
- General principles
  - National laws and regulation, implementation, enforcement and review
  - Employer responsibility
  - Workers required, within the limits of responsibility, to comply
  - Bipartite cooperation





# **ILO instruments - Asbestos Convention**



International Labour Organization

- Protective and preventive measures
  - Exposure shall be prevented and controlled (engineering control, work practices, special rules and practices e.g. authorization)
  - Where necessary and technically practicable: replacement and/or prohibition
  - Prohibition (blue asbestos, spraying)
  - Notification
- Information and education
  - Dissemination of information and education of concerned should be promoted
  - Employers to have written policies and procedures
  - Information of workers

# **ILO instruments - Asbestos Convention**



International Labour Organization

- Surveillance of the working environment and the workers' health
  - Monitoring and recording worker access
  - Medical examinations
  - System of notification of occupational diseases caused by asbestos

35 Countries have ratified, including Australia, Japan and Republic of Korea.

## ILO instruments – Occupational Cancer



International Labour Organization

 Article 2: Each Member which ratifies this Convention shall make every effort to have carcinogenic substances and agents to which workers may be exposed in the course of their work replaced by non-carcinogenic substances or agents or by less harmful substances or agents; in the choice of substitute substances or agents account shall be taken of their carcinogenic, toxic and other properties.

#### 39 Countries have ratified, including Afghanistan, Japan and Republic of Korea.

## **Resolution 2006 concerning asbestos**



International Labour Organization

#### **Resolves that:**

- (a) the elimination of the future use of asbestos and the identification and proper management of asbestos currently in place are the most effective means to protect workers from asbestos exposure and to prevent future asbestos-related diseases and deaths; and
- (b) the Asbestos Convention, 1986 (No. 162), should not be used to provide a justification for, or endorsement of, the continued use of asbestos.





## **Resolution 2006 concerning asbestos**



International Labour Organization

#### **Requests... the International Labour Office to:**

- (a) continue to encourage member States to ratify and give effect to the provisions of the Asbestos Convention, 1986 (No. 162), and the Occupational Cancer Convention, 1974 (No. 139);
- (b) promote the elimination of future use of all forms of asbestos and asbestos containing materials in all member States;
- (c) promote the identification and proper management of all forms of asbestos currently in place;
- (d) encourage and assist member States to include measures in their national programmes on occupational safety and health to protect workers from exposure to asbestos; and
- (e) transmit this resolution to all member States.





## **Current initiatives**



- **Promotion of ratification and effective implementation;** 
  - Advocacy, information, gaps analysis between the Conventions and the national legislation, capacity building to implement;
- Awareness raising among social partners;
- Bringing the possibility of prohibition to the national OSH agenda sometimes as part of OSH and chemicals;
- Detection and diagnosis of asbestos related diseases (training of medical staff);
- Strengthening of national system for reporting of occupational diseases;
- Much focus on the prohibition but the identification and proper management of all forms of asbestos currently in place equally important;
- International cooperation;

- The right to a safe and healthy working environment is respected at all levels,
- Where governments, employers and workers actively participate in securing a safe and healthy working environment through a system of defined rights, responsibilities and duties, and
- Where the highest priority is accorded to the principle of prevention
